### Appointment of Substantive DVCs at Dar es Salaam Tumaini University.

Pursuant to Rule 5(2)(a) of the First Schedule to the draft Dar es Salaam Tumaini University (DarTU) Charter, the DarTU Chancellor has appointed substantive Deputy Vice Chancellors (DVCs) with effect from January 1, 2025 as follows:

#### **1. Prof. Emanuel Amani Mzanyuma Mjema as Deputy Vice Chancellor for Academics, Research and Public Engagement (DVC-ARPE)**



Prof. Mjema holds a Bachelor's degree from the University of Dar es Salaam, Tanzania specialising in Mechanical Engineering; Master's degree in Mechanical Engineering from the University of Alberta, Canada majoring in Management; and PhD degree from the University of Technology Aachen, Germany majoring in Information Technology and Computer Simulation.

Prof. Mjema also attended a special training programme on Innovation and Competitiveness at the Harvard Business School in Boston, MA in 2006.

Prof. Mjema is a full professor with outstanding academic and leadership experience who served as the Rector of the College of Business Education (CBE) from February 2013 to December 2022. Before becoming the Rector of CBE, Prof. Mjema was with the University of Dar es Salaam from 1987, where he started as a Tutorial Assistant and went up the ladder of academic ranks to the position of Associate Professor in 2005. He was promoted to Full Professor of Management in 2018. Prof. Mjema has also served as Chairperson and member of various public and private governing boards and university councils. He is currently the Chairperson of the Governing Council of the Institute of Finance Management (IFM). Furthermore, Prof. Mjema has published more than 50 peer reviewed articles, supervised to graduation more than 60 masters and PhD students, carried out to satisfactory completion more than 15 consultancy projects, participated in the development and review of numerous policies and strategic plans, as well as the development of numerous management information systems.

## 2. Prof. Sylvia Shayo Temu as Deputy Vice Chancellor for Resource Management and Administration (DVC-RMA)




Prof. Temu holds a Bachelor's degree in Commerce, specialising in Accounting, from the University of Dar es Salaam; a Master's degree in Business Administration (*Diplom Kauffrau*) from the Technical University of Berlin, Germany; and a PhD in Business Administration (*magna cum laude*) from the University of Bremen Germany. She also has a Certificate in Technology Management and Cooperation from the Technical University of Berlin, Germany.

Prof. Temu is an Associate Professor in Business Management and a Certified Public Accountant (CPA(T)) with outstanding academic and leadership experience having served as Deputy Vice Chancellor for Research at the University of Dar es Salaam (2012–2013). From 2013-2017, she served as Director of Higher Education in the Ministry of Education, Science and Technology. Prof. Temu has held other administrative positions at the University of Dar es Salaam, including Director of Planning and Finance (2008–2012), Director of University Consultancy Bureau (June 2007 - Oct. 2008), and Deputy Director of the Centre for Continuing Education (Nov. 2001 to June 2007). She has also served as Chairperson and member of various public and private governing boards, university councils and professional organisations. Currently, she is the Chairperson of the Governing Board of the National Board of Accountants and Auditors (NBAA), and Chairperson of the Board of Trustees of the Private Agricultural Sector Support (PASS Trust). Furthermore, Prof. Temu has published about 30 peer reviewed articles, supervised to graduation more than 10 PhD students, carried out to satisfactory completion more than 50 consultancy projects, and participated in numerous other assignments of national, regional and international nature.

The two substantive DVCs are expected to report for duty on Monday, January 6, 2025. DarTUans are hereby requested to accord the DVCs all the cooperation they shall need to efficiently and effectively discharge their respective duties and responsibilities so that together we ably develop DarTU into a remarkably vibrant, dynamic and prosperous private university within the next five years.
